- I. Call to Order Meeting called to order at 7:43 pm by Lisa Curtis.
- II. Director's Remarks Mr. Hoey

  - i. Total deposits: 3434.88 3276 was butter braid orders; 125 craft show vendor deposit and mask sales.
  - ii. Total withdrawals: 2148.26 checks clearing for reimbursing SMB concession items purchased, craft show deposit refund, an apparel invoice and paying CPA for tax return preparation
- c. December: ending balance 43,112.56 of that 23,587.08 student fundraising
  - i. Total deposits: 491.90 321.90 Kroger rewards, show shirt payments, and 6 more masks sold
  - ii. Total withdrawals: 2511 1872 was paying for the Butter Braids ordered, 440 check cleared for SMB videographer, remaining 199 was bank fee
