 - ii. December Holiday Concert will need uniform volunteers, watch for email.
 - iii. A thank you for all the parent help so far this year, please make sure your student has long black socks, not ankle sock. When the bands are judged for events, appearance is part of that criteria, if the judges see "skin" instead of the black socks the band loses points. This can be the difference between 1st and 2nd, every point counts.

- a. Thank-you to all the volunteers that made the SMB show successful. We had 9 bands perform, for a profit of \$3,500. Unfortunately, it was national homecoming day, so several regular bands where unable to attend. However we have no control over the date we are given to host show.

 - ii. Bylaws, we are rewriting our bylaws to be in compliance with district policies.
 - iii. Maximize fundraising, all fundraising needs to be profitable. We are especially working to improve concession profit. We have a lot of new fundraising ideas.
 - b. We are working toward making a better Booster Club.
 - i. We are focused on building bridges with Athletic Boosters, which were a help to us at the SMB show. We are working with Dakota Booster Club, sharing ideas, comparing notes. They will be an asset when dealing with School Board. We are also working with Anchor Bay Booster Club, sharing ideas.
 - ii. We are meeting with the business office to discuss and change policies on individual fundraising and spending, and community fundraising, i.e., "Tag Day". We are meeting again; we are working to negotiate with the School Board to allow us to fundraise money to bring our equipment up to date; instead of taking a onetime payment from them.
